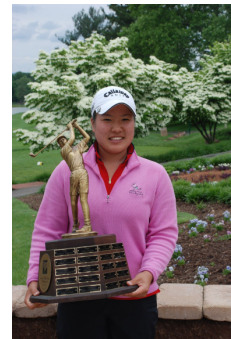

# Tournament Information

**\*\*Please review before completing the application form. \*\***

**Eligibility:** The 2010 Scott Robertson Memorial is open to amateur golfers in two divisions ages 15-18 and ages 14 and under. Applicants who reach their 19<sup>th</sup> birthday on or before May 16, 2010, or have entered college are not eligible. U.S. applicants must have an up-to-date USGA handicap index not exceeding 6.4 for boys 15-18; 11.4 for boys 14 and under, and 18.4 for girls. **All application decisions of the Entries Committee are final.**

**Entry Procedure:** Complete and return the attached application and \$250 (U.S.) entry fee by check or money order by U.S. Mail to the **Scott Robertson Memorial Tournament, P. O. Box 33, Roanoke, VA 24002** or **all overnight services, excluding USPS** to **Entries Chairman Scott Robertson Memorial, 80 Miracle Road, Rocky Mount, VA 24151 (PLEASE WAVE SIGNATURE REQUIREMENT ON OVERNIGHTED DELIVERIES.)**. Your application and proper entry fee must be **received** by 5:00 P.M. (EST), March 19, 2010. **Applications that are incomplete, sent to or dropped off to any other address will not be accepted. Entry fee checks will be cashed at the time the application is received, this does not mean that the applicant has been accepted into the tournament/qualifier field.**

**Dress Code:** Denim pants or shorts are not allowed for players or spectators; in accordance to the Roanoke Country Club dress code.

**Acceptance:** Both Boys and Girls applicants will be accepted into the tournament field this year based on established *Entrance Criteria*. See our web page for complete list of entrance criteria. [www.scottrobertson.com](http://www.scottrobertson.com)

**Notification:** Applicants will be notified by U.S. Mail of acceptance, and the field will be posted on the Scott Robertson Memorial website around the first week in April.

**Refunds:** For complete information on our refund policy see the website at [www.scottrobertson.com](http://www.scottrobertson.com) .

**Caddies/Golf Carts:** Caddies are prohibited. Golf carts for press, spectators or handicapped individuals are prohibited. **No Exceptions.** Assistance for handicapped individuals will be provided.

**Travel & Transportation:** After acceptance, participants using air transportation can book plane reservations into Roanoke Regional Airport. The closest International Airports are Greensboro, NC (2 hours), Richmond, VA (3 hours), Charlotte, NC (3 hours) and Raleigh, NC (3 hours). **Do not make airline travel arrangements prior to confirmation of tournament acceptance, unless you qualify for one of the entrance criteria, categories 1-4, or you are planning to attend a qualifier;** we receive more applications than the tournament fields can accommodate. Information concerning hotel and ground transportation will be provided in the tournament acceptance letter and on our web site.

**Qualifying Information:** In the event that an applicant does not meet any of the entrance criteria (listed on our website) or the applicant's entrance criteria category does not make the field due to the large number of applicants, they will be offered the opportunity to try and qualify into the tournament field. There will be two qualifying round opportunities. Qualifying round #1 will be held on Saturday April 24, 2010. Qualifying round #2 will be held on Wednesday May 12, 2010. Both qualifiers will be held at Roanoke Country Club in Roanoke, VA. Each Qualifier will be limited and will be filled on a first come first serve basis. More information will be available at the time of notification.

The Scott Robertson Memorial Entry Committee guarantees 1 spot for every 14 qualifiers in the boy's 15-18 division and guarantees 2 spots in the girl's 15-18 division for each qualifier. If a player is not accepted, and declares on their application that they will not attempt to qualify, their full entry fee will be returned. If an applicant participates in the qualifier and fails to qualify a \$125 refund will be returned to the player, half of the original entry fee.

Should there be an interest and a suitable number of applicants for the boys or girls 14 and under division, the Entries Committee may consider a qualifier for these divisions on April 24, 2010.

The U.S. Challenge Cup will hold a qualifier for New England residence, the date and further information will be available on their website [www.uschallengecup.org](http://www.uschallengecup.org) .

Our tournament is held in memory of Scott Robertson, a promising young Roanoke Country Club golfer. Scott, a 14 year-old ninth grader, top student and sports enthusiast who had won his age division in several junior golf tournaments, died as a result of infectious mononucleosis in the summer of 1982.

The Scott Robertson Memorial has given over \$200,000 in Scholarships to Roanoke Valley juniors over 22 years. In 2005, our committee launched The Scott Robertson Memorial Junior Golf Academy, which serves as home of The First Tee of Roanoke Valley, a program that provides young people of all backgrounds an opportunity to develop life enhancing values through golf and character education. Through The First Tee of Roanoke Valley, the Scott Robertson Memorial will continue to touch the life of many deserving juniors in the community.
